

ENACTED by the National Assembly of the Federal Republic of Nigeria –

1. The Bees (Import, Control and Management) Act Cap. B6, Laws of the Federation of Nigeria, 2004 (in this Act referred to as “the Principal Act”) is amended as set out in this Act. Amendment of Cap. B6 LFN. 2004
2. Section 5 (1) of the Principal Act is amended - Amendment of section 5 (1)
  - (a) in paragraph (a), by inserting, after the word, “forty” and after the word, “hundred”, the word, “thousand”; and
  - (b) in paragraph (b), by inserting, after the word, “hundred” in lines 2 and 3, the word, “thousand”.
3. Section 6 (1) of the Principal Act is amended by inserting after the word, “forty” in line 6, the word, “thousand”. Amendment of section 6 (1)
4. This Act may be cited as the Bees (Import, Control and Management) (Amendment) Act, 2016. Citation
