
1. The Treaty to Establish African Economic Community Relating to the Pan-African Parliament (Accession and Jurisdiction) Act, 2004 (2005) (in this Act referred to as 'the Principal Act') is amended as set out in this Act. Amendment of Act, 2004 (2005)

2. Article II of the Principal Act is amended by inserting, after paragraph 8, a new paragraph "8A". Amendment of Article II

"8A. On its own, make proposals on the subjects or areas on which it may submit and recommend Draft Model Laws to the Assembly for its consideration and approval."

3. This Act may be cited as the Treaty to Establish African Economic Community Relating to the Pan-African Parliament (Accession and Jurisdiction) (Amendment) Act, 2016. Citation


